We're Accepting Applications for High School Leadership Trip to D.C.

Pella Cooperative Electric will send one student on an all-expenses paid Youth Tour trip to Washington, D.C. in June.

At PCEA, one way we invest in the next generation of rural Iowa leaders is by participating in the National Electric Cooperative Youth Tour program. We're looking for high school sophomores or juniors with a passion for government and public service to apply for a once-in-a-lifetime trip to our nation's capital in June.

One student will be selected from eligible candidates to attend the 2026 Youth Tour in Washington, D.C., from June 14-20 along with 40 other student leaders from Iowa. The Iowa Youth Tour group will join with hundreds of students from across the country as they learn more about electric cooperatives and American history and come home with a greater understanding of their role as an American citizen. Students will also learn about U.S. government and meet with their members of Congress. On the trip, students take in the sights of D.C. as they visit monuments, museums, and historical landmarks. Students who go on Youth Tour often call it the trip of a lifetime!

We are accepting Youth Tour applications through March 20. Children of PCEA member-consumers are eligible to apply. The student must be a current sophomore or junior or currently hold the status equivalent to a sophomore or junior in an accredited home-based school. This scholarship supports students enrolled in an approved Lineworker/Powerline program at the college of their choice, helping cover educational expenses and providing a strong foundation for a future in the power industry.

The PCEA Board of Directors met on December 23 for the December board meeting and discussed the following:

- The Board of Directors approved the 2026 operating and capital budgets, reflecting continued focus on reliability, long-term planning, and responsible financial management.
- The operations department reported on ongoing construction activities. Line crews continue to work on the FEMA mitigation project in the Kilduff area, along with construction supporting the multiple housing developments across the Cooperative's service territory.
- Directors shared key takeaways from the recent IAEC Annual Meeting, where they heard from industry experts on a range of topics, including federal and state legislation affecting electric cooperatives, the future role of nuclear power, and continuing education for directors on key industry issues.

2025 Annual Meeting Minutes



The Annual Meeting of the Members of the Pella Cooperative Electric Association was held at the Pella Christian High School in Pella, Iowa at 7:00 p.m. on the 8th day of April 2025.

Duane Ver Ploeg, President of the Cooperative, presided and called the meeting to order.

Bryce Arkema, Secretary of the Cooperative, acted as Secretary of the meeting and kept the minutes thereof.

An invocations was offered by Director Bryce Arkema.

The Pledge of Allegiance, led by Pella Cooperative's Lance Freml, was next recited by all in attendance.

It was reported by the Secretary, Bryce Arkema, that members present in person (via mailed-in ballots) have been checked and that the following members were present and/or participating in that capacity:

Said members constituting at least 50 members of the Cooperative, President Ver Ploeg announced that the members in attendance constituted a quorum of the members of the Cooperative.

Board Secretary Bryce Arkema commented on the Notice of the Annual Meeting of Members, together with proof of mailing thereof to all members of the Cooperative, as well as the Minutes of the Annual Meeting of the Members held April 2, 2024, which could be read by him. The meeting notice and proof of mailing were then read. A motion was duly made, seconded, and carried to waive the reading of the Minutes. The foregoing was thereupon declared to be approved and was directed to be filed in the records of the Cooperative.

President Ver Ploeg next recognized various guests in attendance at the meeting. In addition, he introduced board members, spouses, and staff members of the Cooperative.

Ellie Schmitz, the Cooperative's 2024 youth tour representative, provided a well-presented video explanation of her trip to Washington, D.C. She concluded her remarks with a thank you to the Cooperative for that opportunity.

The Board President then announced that the report of the Nominating Committee would be read at this time. The Chair of the Nominating Committee, Amy Olsen, then presented the report of the Nominating Committee nominating the following members for directors:

The report of the committee of nominations was ordered to be identified by the Secretary and annexed to the minutes of the meeting.

The report of President Duane Ver Ploeg was then presented. It included a summary of Cooperative operations for the previous year along with a brief explanation of Pella Cooperative's relationship with its wholesale power provider, Central Iowa Power Cooperative (CIPCO). The President's report was then approved and ordered to be filed in the records of the Cooperative.

The annual report of the Chief Executive Officer, Doug Stewart, was next presented. He reviewed operating results for the past year and commented on crew safety and wind and solar energy issues. He also expressed his appreciation for the Cooperative's staff for their quality support and member assistance. His report was thereafter approved and ordered to be filed in the records of the Cooperative.

The Certificate of Inspectors of Election, certifying that the following members receiving the highest number of votes cast had been duly elected Directors of the Cooperative will hold office for the term specified and until their successors shall have been elected and qualified:

Board President Ver Ploeg directed the Secretary to annex the Certificate of Inspectors of Election to the minutes of this meeting and thereupon declared such members duly elected Directors the Cooperative to hold office for the term specified and until their successors shall have been elected and qualified.
